Dear Friends & Partners,

Picture a courtroom hallway. A child sits alone, waiting for someone who actually knows their story.

Then a CASA volunteer walks in — not as a stranger, but as someone who has spent weeks getting to know that child's world. That moment, repeated hundreds of times a year across Anne Arundel County, is the real measure of what this organization does.

Last year, more than 190 children and families moved through our county's juvenile court system — neighbors experiencing a traumatic, chaotic time, who needed someone they could count on as they healed. Our Court Appointed Special Advocates stepped into that role: consistent, caring adults who believe in the power of simply showing up.

That's the part of this work that's easy to overlook. Advocacy isn't only what happens in the courtroom. It's the quiet accumulation of small, consistent choices — a phone call returned, a visit kept, a promise honored — that eventually adds up to a child believing, maybe for the first time, that someone is in their corner.

This past year, we served 124 of the 190 children in care in Anne Arundel County. Getting there meant paying attention to things donors rarely see: strong training, real support for our staff, and advocates who knew they had a team behind them. That's the kind of work that doesn't make headlines, but it's exactly what let 124 children have someone show up for them this year.

As AACCASA enters its 29th year, we've been thinking a lot about time. Not just the hours our advocates log, but what that time actually builds: trust, understanding, a sense that someone is paying attention. We've watched children who once flinched at questions start to laugh again. That shift doesn't happen in a single visit — it happens because someone kept showing up, week after week, until showing up stopped being a surprise and started being something they could count on.

None of it happens without you. Whether you've given your time as a volunteer, your voice as a supporter, or your resources as a donor, you are the reason a child in Anne Arundel County has someone showing up for them today. That's not an abstraction — it's 124 children who had someone in their corner this year, each one changed by a specific person's willingness to stay the course.

Thank you for being that person, year after year.

Our HISTORY

In 1993, a handful of local attorneys recognized the need for a CASA program in Anne Arundel County. With the support from the local Bar Association, the Circuit Court, and the Department of Social



Services, Anne Arundel County CASA, Inc. (AACCASA) was incorporated. AACCASA began serving children in July 1997. With a small staff of five professionals, we rely on volunteers to achieve our mission.

Since our inception, over 762 exceptional CASA volunteers have worked diligently to improve the lives of over 1,004 children in need in our community. Our dedicated volunteers contribute over 10,000 hours of their time annually to help these children who are unable to help themselves. AACCASA is a privately held 501(c)(3) non-profit organization. We are funded through grants, donations, and fundraising and are part of a network of 15 CASA programs serving 23 Maryland counties.

WHO WE SERVE

ABUSED AND NEGLECTED CHILDREN ARE AMONG THE MOST VULNERABLE IN OUR SOCIETY.

Children adjudicated as CINA (Child In Need of Assistance) by the Circuit Court for Anne Arundel County:

- In foster care due to abuse/neglect - NO fault of their own
- Diverse ethnic population
- Up to 21 years of age
- 50% have biological parents who have substance abuse and/or mental health diagnoses
- Nearly 20% of the children are substance exposed, including newborns
- Over 50% of the children have a "mental health diagnosis"

♥ WHAT WE DO

CASA VOLUNTEERS RECEIVE EXTENSIVE INITIAL AND ONGOING TRAINING ON VARIOUS TOPICS:

- Judicial and child welfare systems
- Court report writing
- Impact of family issues: substance abuse, mental illness and violence
- Collaboration, cultural awareness



Our CASAs

CASAS ARE IMMERSED IN ALL ASPECTS OF A CHILD'S LIFE AND:

- Visit weekly with the child
- Review all court and DSS records
- Gather information from EVERYONE in the child's life
- Advocate for the child's needs: medical, psychological, educational and social
- Remain focused that their child finds a stable, permanent and loving home



CHILDREN WITH A CASA...

Spend less time spent in foster care, receive more services, are more likely to be placed with siblings, and have one consistent adult advocating for their best interests.

Anne Arundel County CASA is central to fulfilling society's most fundamental obligation by making sure a qualified, compassionate adult will fight for and protect a child's right to be safe, to be treated with dignity and respect, and to learn and grow in the security of a loving family.

AACCASA achieves its mission through the appointment of each CASA volunteer. A judge appoints a CASA to one foster child or sibling group. The CASA gathers information, ensures necessary services and advocates for the child in court.

**THE CASA IS OFTEN THE ONLY CONSISTENT,
RELIABLE ADULT IN THE CHILD'S LIFE.**

With a CASA, the child has fewer foster care placements, receives more services, is less likely to suffer re-abuse, is more likely to be placed with siblings and more likely to find a safe, permanent home.

Our **IMPACT**

We believe every child who's been abused or neglected deserves to have a dedicated advocate speaking up for their best interest in court, at school and in our community. AACCSA educates and empowers diverse community volunteers who ensure each child's needs remain a priority in an over-burdened child welfare system.



When the state steps in to protect a child's safety because the people responsible for protecting them have not, a judge appoints a trained CASA volunteer to make independent and informed recommendations and help the judge decide what's best for the child.

MAKING IT HAPPEN

- We commit to assisting volunteers, staff, and board in developing a deeper appreciation of the systemic, structural, and generational issues that impact the lives of the children we support to better advocate for their needs.
- We are examining our recruitment strategies to ensure that we are attracting individuals who bring diverse backgrounds and experiences.
- We are continuing to expand our outreach to, and engagement with, community leaders who understand the root causes and systemic issues that bring children into the foster care system to better inform the work we do.
- We are re-committing to reaching community stakeholders regarding the critical importance of the AACCASA program and inviting them to partner with us to create opportunities for the children we serve.



FY26 OUTCOMES

- ▶ 100% of the judges reported that the CASA volunteers increased their ability to make well-informed decisions
- ▶ 92 CASA volunteers were assigned to 124 children, serving 65% of the children in foster care
- ▶ 44 new children received a CASA volunteer
- ▶ 35 new volunteers were trained to support children in need
- ▶ 22 cases closed, placing children in safe, permanent homes
 - 41% were adopted
 - 41% returned home
 - 9% were placed with a relative
 - 5% were living independently at age 21
 - 4% were closed by the court





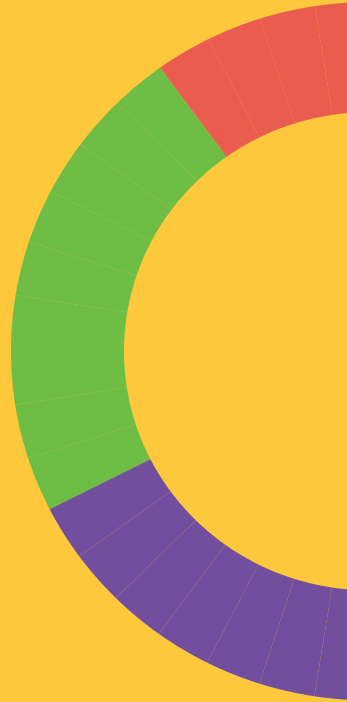
- ▶ 100% of CASAs written court reports were accepted by the Court (154 court reports submitted)
- ▶ 89% of our CASAs recommendations were ordered by the Court
- ▶ Of the 22 children whose cases closed, 95% were living in a permanent home at case closure
- ▶ CASA volunteers donated more than 10,028 hours totaling \$366,128 in volunteer time
- ▶ 100% of the Judges indicate that:
 - They want a CASA appointed to EVERY CINA (Child in Need of Assistance) case.
 - They read the CASA court report before hearing from anyone else as CASA has no agenda other than the best interest of the child.
 - The CASA court report contains the most objective and unbiased information which helps the Judges make informed decisions.

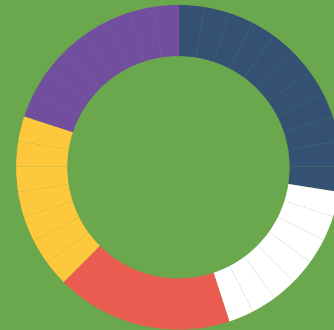

OUR CHILDREN SERVED BY GENDER:



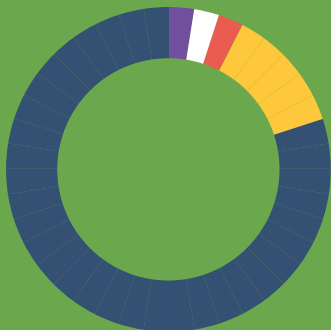

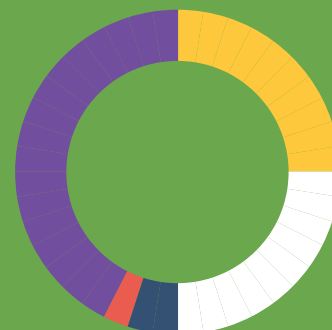
OUR CHILDREN SERVED BY AGE:

- 2% Asian American

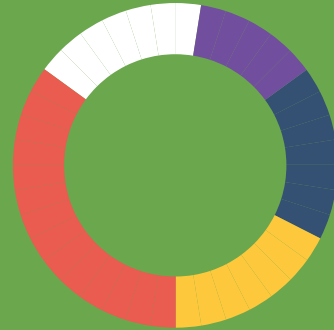

OUR CASAs ASSIGNED BY GENDER:



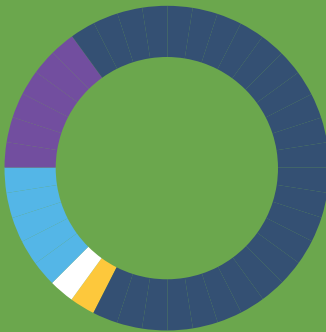

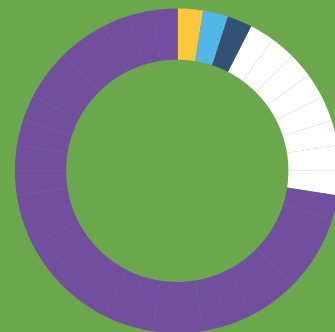
OUR CASAs ASSIGNED BY AGE:
